On 082820 I was assigned as the Operations Chief for events in Portland.

At 1815 a group of about 200 was in front of the Mayor's residence at 937 NW Glisan. At 1817 there were reports that a few people had gone into the lobby and "chained themselves together. We were later able to see a live stream that showed three people were tied together with "sleeping dragon" devices.

At 1818 a vehicle convoy drove near North Precinct and then north out of the area. At 1856 reports were that 100 people were at 13/Gertz that had been associated with the vehicle protest earlier.

At 2210 some dumpsters had been moved into the road near 10/Glisan. The group at this location slowly dispersed after this.

At 2240 A group was gathering in Penninsular Park. The group moved out of the park at 2342. There were about 100-125 in this group. At 0008 the group arrived at the PPA. At 0010 we were able to see the group was already spray painting on the building. At 0014 we were notified the group had cut the power to the building. At 0025 multiple dumpsters and recycling bins had been moved onto Lombard, both east and west of the PPA. At 0028 the three dumpsters east of the PPA were set on fire.

At 0038 the group lit the front of the PPA building on fire. The IC (Cmdr. Dobson) declared the event a riot, and we had ground units start moving in. At 0040 the sound truck gave announcements that the event was a riot, and told people to disperse the area. Force warnings and arrest warnings were included. At 0042 ground unit engaged the crowd and multiple custodies were taken. The fire was able to be extinguished by ground units. At 0100 more custodies were taken. At 0144 ground units disengaged from the crowd at the PPA.

At 0147 a person had climbed on the roof of the PPA briefly but then climbed down on the south side. At 0152 another person was on the roof of the PPA. At 0155 the sound truck gave announcements to the person on the roof that they had been seen and were being watched. He climbed down soon after.

At 0201 several shots were fired at Denver/Buffalo. Delta responded to the scene and secured it for investigation. The sound truck also gave announcements for people to leave the crime scene area. At 0239 ground unit cleared the shooting scene.

At 0240 ground units were demobed.
